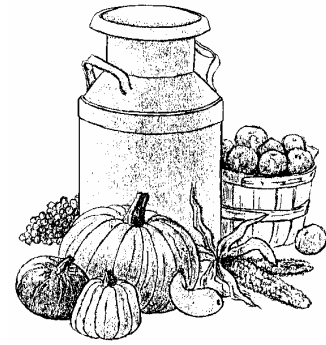

Ensuring the Legacy – June 2-4, 2004

Our annual conference, entitled “*Ensuring the Legacy*” was held at St. Michael’s College in Toronto last June. Sr. Marie Marchand, OSU, from the Regroupement des Archivistes Religieux presented that group’s report on “The Future of Archives”. In a letter to Jacques Monet, SJ, Sr. Marie expressed her appreciation of “our open exchanges concerning our mutual preoccupation – the future of our religious archives...If other inquiries arise or if, on our part, other developments occur, because the Quebec project is stimulating other diocese, I would be pleased to share the available information.”

Following up on the theme, Sisters Juliana Dusel, IBVM, and Rita McGuire, GSIC, gave case studies of their own congregations and Marc Lerman gave practical tips for moving archival collections. This was timely because some religious organizations are now making decisions about their future by downsizing and moving to new locations.

Tom Belton, the Archives Advisor of Ontario gave a short presentation on archives design and Dr. Mark McGowan gave a memorable address at the opening dinner on the church historian and the religious archivist as “Partners in

Preservation". A special thank you goes to Jacques Monet, SJ, for arranging the bus trip to Midland. The tour of the Canadian Martyrs' Shrine and Sainte Marie among the Hurons, the Liturgy at Brebeuf's grave and the dinner at Sainte Marie among the Hurons were truly a highlight.

Of necessity, business matters occupied part of our time together. Members of the Interim Executive reported to the group and presented constitutions for ratification. Conference participants shared ideas for future conferences and elected the Executive and Planning Committee members. Saskatchewan Centennial

100 The province of Saskatchewan will be celebrating its centennial in 2005. One centennial project is the encyclopedia that is being prepared for the province. Some congregations have already submitted an article for this project. As well, a conference is being planned to remember and celebrate the contribution that religious congregations have made and are still making in the province. The conference, entitled "Shaping a Gentle Province: The Contribution of Catholic Sisters in Saskatchewan", is planned for September 9-10, 2005 in Saskatoon. Forty-two religious

congregations that have served in the province are being asked to participate.

Archivists will have a key role in the preparation and presentation of the historical information. The conference planners are asking for presentations, visual displays and listings of names of religious with Saskatchewan connections. This will be an opportunity for archivists to showcase some of the rich resources in their archives and heritage rooms.
